*Scott discussed the Executive/Administrator Environmental Health & Safety Summery report that was sent out August 15<sup>th</sup> to the CCS President and Managers. The report included several environmental activities conducted over the summer months including curb paint removal and*

disposal, waste oil disposal and eye wash shower inspections. There are 51 AED units on the SCC campus with 2 units in security vehicles. The units are inspected weekly.

**Electrical Safety Guideline Written Procedure** is in draft. We need input and editing for final draft. Scott discussed **Hazard Communications** four points.

- Employee training
