

## es Spokane Community College PACE Services STUDENT CODE OF CONDUCT AGREEMENT

Student conduct that distracts from or interferes with the college being able to serve its students and/or interferes with students' opportunities to learn in a safe environment is not acceptable.

Admission to PACE Services programs carries with it the presumption that students will conduct themselves as responsible members of the academic community. This includes an expectation that students will obey the law, will comply with rules and regulations of the college, will maintain a high standard of honesty, and will respect the rights and property of others.

## STUDENTS ARE EXPECTED TO FOLLOW THESE RULES:

- No smoking, including electronic cigarettes, except in designated areas
- No possession or under the influence of alcohol, illegal drugs, controlled substances, or marijuana
- No possession of firearms or weapons, including paintball guns, air guns, and any other items that shoot projectiles
- No misconduct or disruption of any college class, function, or activity
- · No theft or damage of college or other students' property
- No violence, harassment or intimidation to any person, including physical contact, verbal, non-verbal, written, social media, and electronic communication
- No stalking of another person
- No reckless endangerment to others or property
- · No assaultive behavior, no bullying, or verbal threats
- No abuse or theft of CCS information technology
- No academic dishonesty
- No sexually violent conduct including domestic violence, dating violence, stalking, cyberstalking, indecent liberties, voyeurism, nonconsensual sexual intercourse and nonconsensual sexual contact
- Do not discriminate
- No trespassing, including the use of unauthorized keys, keycard, or other restricted means of access to college premises, or unauthorized entry to or use of college premises

- · Comply with requests of college officials
- Must demonstrate a competence to benefit from the curriculum offerings
- Must not abuse self, including physical abuse, threats, intimidation and or other conduct which threatens or endangers the health or safety of one's self
- No disorderly conduct or participation in any activity which disrupts the operations of the college or infringes on the rights of another member of the college community, including conduct that is disorderly, lewd or indecent, disturbs the peace, or assists or encourages another person to disturb the peace
- No sexual harassment including unwelcome gender-based conduct
- No unauthorized use of electronic or other devices, including making an audio or video record of any person while on college premises without his/her consent, if the recording is likely to cause distress or injury
- No reckless endangerment that creates an unreasonable risk of harm to another person or property, or is perceived as threatening the health or safety of another person or property
- No aiding, abetting, inciting, encouraging or assisting another person to commit any acts of misconduct

Students who violate the code of conduct have rights that include being notified in writing of their alleged violation and the right to a prompt, fair and impartial hearing. Students have the right to bring a supporter with them to attend any meetings to discuss the violation to tell their side of the story to a school official. Students also have the right to appeal any disciplinary decision by the student conduct officer or student conduct board or panel.
